Engineering/Plant:

Anthony reported that the south boiler repair is finally completed and we are back to two boilers. However, we are having issues finding a thermo coupling for the co-generator and cannot run it without this part. The co-gen is a German made product and finding parts has been a problem since we got it. We found thermo couplings that would work but the threads are wrong and we're having a lot of trouble. If it's the right thread it's the wrong thermo coupling. No one has them. Joe Reuben asked if it was possible to get something close, take it to a machine shop and have them thread it for us? Anthony stated that we're trying to work with these guys that have worked on the co-gen for years and they're doing a lot of the research and they're having a hard time.

Joe Reuben asked about the building plans and Tyler reported that we've reached out to people several times to see what route we want to go. Some were too busy and now I'm waiting for another reply. Anthony stated that we are looking at stick built. We may possibly be looking at a conventional build. Joe Reuben asked if we could go to a pre-

manufactured building and how big is the building? Anthony stated it's 60 x 40. It has four showers, toilets, a room to eat lunch, a washer and drier and a big locker room with around 24 lockers and benches. It's basic with a concrete floor. We're not asking for a lot. Getting people to call you back is not easy either.

Joe asked about the solar company was still in touch with us and Anthony stated that they wanted another five-acre area where we apply sludge and we showed them another area so we're still talking.
