# THE LANDIS SEWERAGE AUTHORITY REGULAR MEETING March 4, 2024

It was moved by Barse and seconded by Miranda that the reading of the minutes of the regular meeting held on February 20, 2024 be dispensed with and the same be approved in the form submitted to all members by mail. Roll call: Barse, Miranda, Angelo and Reuben voted "yes".

The Chairman asked if there were any general public comments or comments on the proposed Resolutions. There were none.

#### **Resolutions:**

It was moved by Barse and seconded by Miranda that Resolution No.2024 – 18, "Be it resolved by the Landis Sewerage Authority, that the following bills of items or demands are hereby approved and authorized for payment out of the Revenue Fund Revolving Payroll Account.... \$105,265.53", be adopted. Roll call: Barse, Miranda, Angelo and Reuben voted "yes".

It was moved by Barse and seconded by Miranda that Resolution No. 2024 - 19, "Be it resolved by the Landis Sewerage Authority, that the following bills of items or demands are hereby approved and authorized for payment out of the Revenue Fund Bills.... \$298,229.15", be adopted. Roll call: Barse, Miranda, Angelo and Reuben voted "yes".

It was moved by Barse and seconded by Miranda that Resolution No. 2024 - 20, "A Resolution of the Landis Sewerage Authority, revising the Landis Sewerage Authority allocation policy, administrative review, contract operations and emergency repair cost reimbursements, costs schedule to be known as CRS-2024..." be adopted. Roll call: Barse, Miranda, Angelo and Reuben voted "yes".

It was moved by Barse and seconded by Miranda that Resolution No. 2024 - 21, "A Resolution of the Landis Sewerage Authority, authorizing Executive Director to award a contract to Final Touch Contracting, LLC in the amount of \$109,850.00 for restorations of existing sewer trenches throughout the City of Vineland..." be adopted. Roll call: Barse, Miranda, Angelo and Reuben voted "yes".
